**GED Registration Requirements**  
**The GED consists of five tests. Each test costs \$19. Entire group is \$95.**  
**Money Order is the only acceptable form of payment.**

**20 years old and older**

1. Bring any valid State Picture ID, Passport, Military ID, etc.
  2. The first time candidate must complete a demographic form and other registration documents.
- For the previously tested candidates, the student test history will be reviewed to determine eligibility for testing.

**18 or 19 years of age**

1. Bring any valid State Picture ID, Passport, Military ID, etc.
  2. The first time candidate must complete a demographic form and other registration documents.
  3. Must provide a school withdrawal form from the last school attended.
- For the previously tested candidates, the students test history will be reviewed to determine eligibility for testing.

**16 or 17 years of age**

1. *All candidates 16 or 17 years of age must attend GED Classes and fulfill all requirements as established by the GED National Offices in Washington, DC. For more information on GED Classes please call 404 802 3560.*
  2. After fulfilling all requirements related to the GED Classes the candidate may then come to register for Official GED Testing. Candidates must bring the ***Special Needs Testing for Youth Under Age 18*** packet provided to them at the completion of the GED Classes which includes the completed and appropriately signed:
    - Underage Youth Request for Special Permission to Take the GED Test Form
    - Parent/Guardian Consent Form
    - Recommendation to take the GED Tests (*This document is completed by the GED Class Administrator. Please call 404-802-3560 for more information on GED Classes and recommendation to test.*)
    - Must provide a school withdrawal form from the last school attended.
    - Bring any valid State Picture ID, Passport, Military ID, etc.
    - The first time candidate must complete a demographic form and other registration documents.
    - Completed documents from the ***Special Needs Testing for Youth Under Age 18*** packet will be forwarded to the state office for approval. (*This step is done by the Chief Examiner at the Official Testing Center.*) Please note that to allow the GED state offices sufficient time to approve underage candidates said candidates testing schedule(s) will normally be assigned about two months from the date of registration.
    - Candidates who will be 18 by the scheduled test date will be allowed to register if a school withdrawal form from the last school attended is provided with the same requirements as noted under category above for those 18 and 19 years old.
- No person under the age of 16 is allowed to attend GED Classes or register for Official GED Testing.
